Food was removed from hot holding, placed in the oven until reaching a 165F temperature, and moved back to hot holding ready for service. COS. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
<p>Violation #22. Cold holding temperatures Chopped fruit observed at 50F in cold holding. Food was placed back in the freezer until reaching a temperature below 41F and moved back to cold holding ready for service. COS. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
<p>Violation #55. Facilities installed, maintained, & clean Garland oven with WO#10160250 observed out of service. Repair or replace damaged equipment. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
